

**REVISED AMENDED ORDER DESIGNATING DAY OF WEEK AND LOCATION OF  
REGULAR TERMS AND SETTING SCHEDULE OF FAYETTE COUNTY  
COMMISSIONERS COURT REGULAR MEETINGS FOR 2019**

In accordance with Section 81.005(a) (Terms of Court, Meetings), Local Government Code, the Fayette County Commissioners Court (the "Court") by Order approved and signed on December 26, 2018 (the "December 26, 2018 Order") set and ordered "... that regular terms during 2019 shall be held on the 2nd and 4th Monday of each month...", and accordingly adopted a schedule of regular meeting dates to be held on Mondays (two dates are on a Tuesday, when the preceding Monday is a holiday).


**IT IS THEREFORE ORDERED** by the Fayette County Commissioners Court, in accordance with Section 81.005, Local Government Code, that the Fayette County Commissioners Court terms and regular meetings shall be held at the County Seat at the Fayette County Courthouse, 151 North Washington Street, La Grange, Texas 78945 in the Commissioners Courtroom, Third Floor, Room 303, of the Fayette County Courthouse. The Court, by the December 26, 2018 Order, has designated, set and ordered that regular terms of one week during 2019 shall begin on the 2<sup>nd</sup> and 4<sup>th</sup> Monday of each month and, by authority of Section 81.005(h), Local Government Code, the Court hereby amends the December 26, 2018 Order as to the day of the week that the Court meets during the weekly terms, and **THEREFORE HEREBY FURTHER ORDERS** that Thursday shall be the day of the regular meetings of the Fayette County Commissioners Court during the aforesaid weekly terms that commence on the 2nd and 4th Monday of each month, commencing on Thursday, February 28, 2019, except that a meeting shall also be held on Monday, August 26, 2019, and except for the meeting to be held on Monday, December 23, 2019 (because Thursday, December 26, 2019 is a County Holiday), and except for the meeting to be held on Wednesday, November 27, 2019 (because Thursday, November 28 is the Thanksgiving holiday).

**Accordingly, regular meetings of the Fayette County Commissioners Court during 2019 shall be held on:**


Additional regular meetings, if required, may be called and held in 2019 during the regular weekly terms. Special meetings may also be called and held in 2019.


