Essential Needs/Restricted License County Court, Fayette County, Texas

This license is for someone who has had their license suspended once or twice due to DWI, Possession Charges or traffic violations. It is not valid for a CDL license but you may apply so that you can drive to and from work. The issuance for this temporary license would be for persons who have received a suspension in Fayette County or reside in this county. If the suspension was for a case here in Fayette, we will notify the County Attorney's Office of your application. If your case is in another county, you need to notify the County Attorney of that county, that you are applying for the license before you apply, that is the law.

If this should be your second offense, you should have been given an order when you were magistrated to have a blow device installed in your vehicle. If so, please have it installed and bring proof before you file your application. You should also check with DPS to make sure you are eligible and ask for the date you qualify for a restricted license. If you were not given paperwork for the blow device and this is your second DWI charge, we will need the Judge to Order that first.

The fee to file the application is \$222 plus additional fees after the hearing for your certified copy and copies for DPS. This is usually less than \$30 depending on the length of your application. The application and the order must be filled out with the same information at time of filing. The license will be issued for maximum of 6 days a week for 12 hours of driving time per day. The hours may be broken down, but must not exceed 12 hours. You also need to list all counties that you will be traveling through. For example, if you travel to Houston to work, you will need to include all of the counties you travel through to get there.

Also at time of filing, Judge Janecka requires a copy of your SR-22 and a copy of your driving record. You may apply for the SR-22 with your insurance company and with DPS, www.dps.texas.gov, for the Certified Abstract Record of your driving record. After application and payment, a hearing date will be set with Judge Edward Janecka. If you have everything with your application and the Judge is in, we could have the hearing set the same day. Please dress appropriately for a court hearing (pressed shirt tucked into nice jeans or slacks, NO t-shirts or shorts and the Judge is not a fan of piercings so please remove those before the hearing)

After the hearing and the Order is signed, we will make you a certified copy to carry with you along with your log that you must keep.

NOTE: THIS ORDER IS ONLY GOOD FOR 30 DAYS.

You have 30 days to send to DPS a copy of the application and order, SR-22 and your reinstatement fee. That fee is \$100-\$125 depending on your charge. You will need to check with DPS on that fee. They must receive all of this information in order to issue your temporary license. It will be a hard plastic license just as your driver license. This along with your log is what you will need to carry throughout your suspension. **Again, the order that we issue is only good for 30 days.**
