You have been issued a citation, which will be filed in the Justice of the Peace Court, Fayette County, Texas in the court that is circled above. **PLEASE REVIEW YOUR OPTIONS ON THE REVERSE SIDE OF THE FORM BEFORE CONTACTING THE COURT.**

You have the right to a trial. At the trial, you may, at that time, present your case to the court, with or without an attorney. **Mail Form D on the reverse side of this page on or before your appearance date shown on the citation.**

You may be eligible to receive Deferred Disposition. If you request Deferred Disposition, and it is granted, the citation will not appear on your driving record. **Mail in Form B on the reverse side of this page on or before the appearance date shown on the citation.**

You may be eligible to have this charge dismissed by successfully completing a Driving Safety Course or a Motorcycle Operator Training Course. You will lose that right if, on or before your appearance date, you do not provide the court with notice of your request to take the course. You are eligible to take a Driving Safety Course if you meet the following requirements: (1) You have a Texas Driver's License and you were NOT cited for 25 miles or more over the posted speed limit, and you were NOT driving 95 mph or more. (2) You have not taken a Driver's Safety Course in the last 12 months to dismiss a citation. (3) Remit payment in the amount of \$112.00 (4) Remit a copy of your auto liability insurance policy card. **Mail in Form A on the reverse side of this page on or before the appearance date shown on the citation.**

If you have a Commercial Driver's License you are NOT eligible for the Driving Safety Course or a Deferred Disposition.

To enter a plea of "NOT GUILTY," Mail in Form D on or before the appearance date and you will be set up a different date and time for your day in court.

Should you fail to respond to the citation in any manner, a charge of "VIOLATE PROMISE TO APPEAR" will be filed against you. Warrants will be issued, and you will be subject to arrest at any time. REMEMBER A PHONE CALL IS NOT CONSIDERED AN APPEARANCE. YOU MUST CONTACT THE COURT EITHER IN PERSON OR IN WRITING. ENCLOSING A SELF ADDRESSED STAMPED ENVELOPE WILL ASSURE RECEIVING COURT DOCUMENTS PROMPTLY.
