

PUBLIC SERVICE ANNOUNCEMENT

Fayette County has received a Texas Community Development Block Grant (TxCDBG) contract under the Community Development Fund from the Texas Department of Agriculture. In order to comply with the Civil Rights requirements of Title I of the Housing and Community Development Act and the Fair Housing Law, Fayette County has established policies, plans and resolutions to ensure that equal opportunities are afforded to all persons and that no person shall be excluded or denied program benefits on the basis of race, color, religion, sex, national origin, or age. Policies include the following:

FAIR HOUSING PUBLIC SERVICE ANNOUNCEMENT

To promote fair housing practices, Fayette County encourages potential homeowners and renters to be aware of their rights under the National Fair Housing Law. Title VIII of the Civil Rights Act of 1968, as amended, prohibits discrimination against any person on the basis of race, color, religion, sex, disability, familial status or national origin in the sale or rental of units in the housing market. CITIZEN PARTICIPATION & GRIEVANCE PROCEDURES NOTICE FOR THE TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

Fayette County has adopted complaint and grievance procedures regarding its Texas Community Development Block Grant (TxCDBG) Program. Citizens may obtain a copy of these written procedures at the Fayette County Courthouse, located at 151 N. Washington, La Grange, Texas 78945 between the hours of 8:00 am and 4:00 pm Monday through Friday (except holidays). Citizens may also request the procedures be mailed to them by calling the County Judge's Office at (979) 968-6469. These procedures outline the steps for a citizen to follow if he/she wishes to file a complaint or grievance about TxCDBG activities. A person who has a complaint or grievance about any services or activities with respect to the TxCDBG project, may submit such complaint or grievance, in writing to the County Judge at the Fayette County Courthouse, 151 N. Washington, La Grange, Texas 78945 or may call (979) 968-6469. Fayette County will make every effort to respond fully to such complaints or grievances within fifteen (15) working days where practicable after receipt of the original complaint or grievance.

SECTION 3 POLICY

Fayette County has adopted a resolution to further Federal Section 3 compliance. Through the adoption of this resolution, the County strives to attain goals for compliance with Federal Section 3 regulations by increasing opportunities for employment and contracting with Section 3 residents and businesses where feasible.
