November 12, 2024 Austin County Commissioners Court met in the 2nd floor Courtroom at the Austin County Courthouse with the following present:

4. Discussion and action to accept resignation of Todd Morris, Justice of the Peace, Pct. 2.

Judge Lapham presented Todd Morris (Justice of the Peace, Pct. 2) resignation letter from Justice of the Peace, Pct. 2 position and his transfer back to Austin County Sheriff's Department effective November 19, 2024.

5. Presentation of Texas Commission on Jail Standards Comprehensive Inspection Report conducted October 23-24, 2024.

Per Sheriff Jack Brandes, Austin County Jail was in compliance with Texas Minimum Jail Standards. Captain Valdo Paredes and Lieutenant Ervin Montgomery were commended for their excellent work in maintaining cleanliness and organization of jail.

Captain Valdo Paredes addressed that passing jail inspection helps future inspections by remaining at lower lever, and not having on-sight inspections until following year.

Per Judge Lapham speaking on behalf of Commissioner Court side, he appreciates all jail staff for always maintaining professionalism, speaks highly of leadership.

6. Discussion regarding property division and action as appropriate.

Per Judge Lapham, property division over 10acres, that have road frontage and no roads are constructed normally don't need court approval. Land that creates one lot or more less than 10acres will have to go to court for approval. Family partitions are also not brought for approval, as long as all guidelines are followed.

Per Jonathan Hopko (County Engineer), there are exemptions in state code that are granted to the county to allow land division without plating. An example, Waller County, has a letter of plat not required form with engineer signing off. He does not mind taking responsibility if court agrees to take over letter of plat not required, but he suggests that there be two signatures, Engineer signature of approval and Judges signature as a Representative of the Court.

Judge Lapham inquires that as long as guidelines are followed, and land is over 10 acres, should land owners come to court.

Per Judge Lapham, if letter of plat not required form is provided, they will have to add verbiage stating whether needs court approval, or if meets requirements does not need court approval.

Per Sergeant Darracq, Chief Matt Walls is currently driving a 2019 Ford F-250 and request Commissioner Court to allow removal of truck from inventory, and use it as a trade in for new vehicle. Difference will be paid with Sheriff Discretionary fund. Vehicle being requested is a Chevy 1500 (Special Police Package Vehicle). Serves the needs of Chief Matt Walls that responds to certain calls.

Chief Matt Walls, addressed that before being promoted to chief he was already driving a Chevy, so all equipment was removed form vehicle and placed in storge. Which is why they deciding to proceed with new 2024 Chevrolet Silverado to add stored equipment from previous truck.

Per Commissioner Rinn, Pct. 2 is looking to purchase new vehicles, and asked if instead of 2019 Ford F-250 being traded in can vehicle be switched over to Road and Bridge Department.

Judge Lapham clarified Road and Bridge will pitch in the \$23,500.00 trade in value for the 2019 Ford F-250 to be transferred over to their department.

Per Sergeant Darracq, the deal should not be affected, pricing will just go back to original value.

Per Judge Lapham discussion 7a. 2019 Ford F-250 will not be declared as surplus, vehicle will just be switched to Road and Bridge Department.

Per Judge Lapham discussion 7b. approve trade in of 2019 Ford F-150 will not be approved.

Commissioner Cerny motion to approve discussion 7c. purchase of 2024 Chevrolet Silverado at \$30,335.00 for Sheriff's Department.
