Cookie Curry thanked the Court for the grant they received. She spoke about the Census affecting their funds. They are in need of volunteers.

### 3. Discussion regarding Inmate Care Contract and action as appropriate.

Per Sheriff Brandes, State is mandating Tele-Psych with license psychiatrists. He addressed the Court with seven Jail needs. Last year \$136,606.03 was spent on medical for Jail.

Dr. Don R. Bosse, M.D. addressed the Court with his bid of \$96,295.

Tim Quinton (Southern Health Partners, Inc.), addressed the Court with his bid of \$88,000.
