August 13, 2018, Austin County Commissioners Court met in the Commissioners Court Meeting Room at the Austin County Courthouse with the following present:

1. Petitions or Requests from the Public.

Buddy Koenig, Republican Party Chairman, invited the Court to the Austin County Banquet at the Austin County Fair Grounds on September 8, 2018. Tickets are available for purchase.

2. Discussion and action regarding construction projects and finance options (Jail, S.O., E.M.S. Station)

Kenneth Burns, Burns Architecture, LLC, had no update from last Court. Judge Lapham presented several options to the Commissioners. 2007 bonds are paid off. County can pay off 2009 bonds and issue Certificates of Obligation for entire \$9.5 million. Can refinance 2009 bonds and use funds toward project along with Certificates of Obligation for remainder

needed. 2009 bonds are due to be paid off in February 2019. There is roughly \$3.5 million in the General Fund.

Mr. Burns advised the Court funds will need to be in the bank at the time construction contract is signed.

Cash on hand can be used to pay preliminary and design costs. Can use Certifiecates of Obligation for the Jail and Sheriff's Office. The JP Pct 1 will not be included.

The Court discussed the timing of Certificates of Obligation and Bond election. If the Bond election passes doesn't mean County has to borrow \$17 million.

Court intends to use Certificates of Obligation for \$9.5 million for the Jail and Sheriff's Office and have Bond Election for \$17 million for Justice Center (\$15 million), EMS station (\$1 million), and LCRA (\$800,000) to move powerline.

Judge Lapham presented the Court with possible numbers for repaying Bonds. See supporting documents.

Requests 113 - \$3,895,197 and 114 - \$1,906.351.

Proposed budget works, but doesn't include requests from the Sheriff's Office or additional raises for Constables 3 and 4.

Including requests for Departments 113 and 114, adding \$45,000 for Constable Precinct 3 and 4 salaries, and EMS requests leaves a deficit of \$589,696. Court asked Ron Dille, EMS Director to review his budget. Per Ron, numbers submitted are to fully staff Industry and Wallis EMS stations. Staffing Industry station only, would reduce requests by approximately \$200,000.

If the tax rate for the General Fund stays the same, it will cover the proposed budget.

Per Sheriff Brandes, there will be funds left over in the budget because Jail is not fully staffed. He requested time to run the numbers to get budget down to \$3,739,414.

Will adopt at next Court date.
