Charlotte Kirk, Houston Regional Service Manager with Texas Department of Motor Vehicles presented award to Kim Rinn, Tax Assessor-Collector.

2. Petitions or Requests from the Public.

Shannon Hannath, Commissioners Administrative Assistant, spoke with regard to the online County auction beginning Wednesday, July 10, 2019 and ending July 24, 2019. Each vehicle starts at \$500.00. Will run the auction each quarter.

Aaron Brandes spoke with to the condition of Grubbs Road.

4. Discussion and action as appropriate regarding building projects and financing.

a. S.O. / Jail

Having issues with old A/C units. Per Kenneth Burns (Burns Architect), there is an invoice for two of the remaining four units. Burns has requested an estimated cost of a split system so it could be reused in the newer building at a later date.

Relocation of a radio equipment next to the big tower. Harris County going to donate a building, but needs a foundation for it.

Demolition has begun, but held up due to black mastic being found. Black mastic has been sent for testing.

Per Randy Reichardt (*Commissioner, Pct. 3), the Jail Commission will pay for cameras and electronic check in for the Jail. Burns to check on the requirements to use the money.

b. Justice Center

Per Burns, a meeting is needed with TXDot. Will have Civil Engineer present.

Per Burns, needs to speak with Judge Leedy about courtrooms with regard to furniture for the courtrooms.

Burns will spend time with Users with regard to plans.

c. EMS

Construction Manager has been contracted someone for fire protection to ensure we have proper water flow. Plans will be complete by mid-August. Building has filled the space. Civil Engineer asking about off-site retention. Vykukl Lake is a possibility.

5. Discussion and action to amend compensation order to change one part-time position in Tax Assessor/Collector's Office to full-time effective July 1, 2019.

Kim Rinn requested that one of her part-time positions become full-time.

Commissioner Reichardt asked why there is \$70,000 padded in the budget? Per Judge Lapham, the Compensation Order is budgeted for maximum pay for each position. If a position isn't making max pay, there is extra in the salary line item.

9. Presentation by Austin County Appraisal District regarding change in homestead tax exemptions.

Per Greg Cook, Chief Appraiser with Austin County Appraisal District, per statue the County can't have a base \$5,000 exemption for every home owner, it must be by percentage. Homestead Value exemptions at 1% affect homes valued at \$500,000 or more and 2% affect homes valued at \$250,000 or more. Cook's recommendation is 2% for County, 1% for F/M, and 1% for Special Road and Bridge.
