Comptroller's office sent letter stating a company erroneously keyed their sales and use taxes to go to Austin County instead of the City of Austin. County has to pay Comptroller back \$250,016.54 for funds paid to County in error.

Three options to pay the funds back. Option #1: Pay in full. Option #2: Apply all monthly collections to the overpaid amount until repaid. Option #3: Enter into a 32-month payback agreement.

This has happened before. County is currently repaying an overpayment from several years ago.

Court chose Option #3.
