1. PUBLIC HEARING ON PROPOSED TAX RATE

Pat May asked if Road and Bridge and FM Lateral rates could be lowered to the 2015 rates?

Public hearing closed 9:05 a.m.

2. Petitions or Requests from the Public.

Phillip DePawk, Nancy DePawk, Lyndou Bolen, and Kelli Stark (residents who live in Gindorf Estates) spoke with regard to issues with roads in the area. There have been at least four accidents.

Pat May requested to make employees aware that Item #12 doesn't cancel taxes.

3. Discussion regarding Burn Ban and action as appropriate.

Lift Burn Ban.
