3. Discussion regarding Austin County Subdivision Regulations proposed changes and action as appropriate (reminder public hearing on proposed changes will be March 22, 2021)

Public Hearing on March 22, 2021 at 9:00 a.m.

Per Judge Lapham, City of Sealy decided to rescind their interlocal agreement with County. County has authority over EJT. Commissioner Rinn proposed a change on page 29 for width-to-depth ratio for lots not to exceed 1:3 instead of 1:4.

Joy Jennings addressed the Court with concerns about the subdivision regulations not being followed.

4. Discussion and action as appropriate regarding building projects and financing.

Per Kenneth Burns (Burns Architecture), Sealy EMS is complete. Will close everything out on Burns' end. Jail and SO should be receiving consoles in today. Furniture should be coming. Last of demolition has been done. Inmates should be able to return in 90 days. Justice Center is going along well. Bids for furniture for Justice Center should go out today.

Two bids for filing systems were submitted by Southwest Filing and Storage – Lindy Stull for \$248,055 with life time warranty and Southwest Solutions – Carlyle Ordner for \$235,129.67 with seven-year warranty. Bid for extra section wAS submitted by Southwest Filing and Storage – Lindy Stull for \$1,562.00. Total bid from Southwest Filing and Storage – Lindy Stull \$249,617.00. Kenneth Burns recommends Southwest Filing and Storage. Bid includes relocation of existing filing system. Cost already budgeted for.

Award to Southwest Filing and Storage - Lindy Stull.
