Mark Young informed the Court he will be filing a petition to have discontinued road be reestablished as a third-class road.

Per Commissioner Reed, tire recycle event went smooth. He thanked the Road and Bridge employees for helping.

Per Kim Rinn (Tax Assessor-Collector), the registration extension will expire on April 15, 2021. She encouraged everyone to get their registrations and titles transferred.

3. Discussion regarding Subdivision Regulations and action as appropriate.

Per Commissioner Rinn, subdivision regulations were approved with revisions, but not sure the Court has the legal authority to make those changes. Per Judge Lapham, he asked Bob Bass (Allison, Bass & Magee) for a template, but Mr. Bass wasn't willing to give a template and couldn't give an estimate for going over the County's subdivision regulations.

Per Commission Lamp, he is concerned with TECQ.

The Court came to the conclusion the septic ordinance needs to be reviewed. Commissioner Rinn suggested Planning and Development look at complaints then draft a letter to TECQ. Bring the letter to Court to be approved. Once the letter is approved then send to TECQ.

Per Commissioner Reed, building in Wallis is coming along. Per Commissioner Rinn, still waiting on contractor to come out. Per Walter Morrow (EMS Director), still working on garage issues. Waiting on parts to arrive. Per Sheriff Jack Brandes, Sheriff's Department is looking good. Received furniture. There was an issue, but was able to get it fixed. Will receive second shipment tomorrow.

Per Commissioner Reed, work on Tomlinson, Tower and Kloptstedt Roads is going well. Per Commissioner Rinn, adding 2"-3" of limestone to West Ueckert. Per Commissioner Lamp, changing culverts on Steck Bottom Road. Per Commissioner Cerny, still discussing bridge on Kulow and Cat Spring Roads with Colorado County.

7. Discussion regarding Wendt Street Building update and action as appropriate.

Commissioner Rinn thanked the departments at Wendt Street. Each department gave a punch list.
