Motion to Approve: Commissioner Lamp, 2nd Commissioner Rinn, passed (4-0). **Order #22-86**

1. Petitions or Requests from the Public.

Commissioner Rinn thanked the EMS department for their professional services and quickly coming to the aid of him and his wife. Tammy Rinn is recovering well.

Mike Blommer addressed the Court with concerns about ESD #1 meeting.

2. Open bids for Pct. 2 road projects:

- a. Shelby Road
- b. Emshoff Road

Received bids for Shelby Road project from Wakefield Bridge, Inc. for \$244,285 and TCB Construction, Inc. for \$366,866.

Received bids for Emshoff Road project from Wakefield Bridge, Inc. for \$251,030 and TCB Construction, Inc. for \$381,742.

Bids will be reviewed then brought back to next Court meeting.

3. Open bids for construction at Wendt Street Building

Per Commissioner Reed, no bids were received. Commissioner Reed and Commissioner Rinn will put together a bid packet to send to contractors. Will bring back next Court.

Per Judge Lapham, resolution is in regard with HGAC helping County with Hazard Mitigation Plan. They have a grant that will help cover that. Roy is working on it just needs to be updated. There is no match for this grant.

Per Judge Lapham, Switzer Auction has started to advertise the Adult Probation building to dispose of. They have a sale scheduled for some time in May. We pushed it a month after we plan to have them out of there so potential bidders have time to look at the building. Will walk through Justice Center to make sure we are on track for all the little things that need to get finished.

Per Judge Lapham, this isn't all the chairs needed. These are just to get started. Will figure out how many more chairs needed. Plan on everyone taking chairs they are sitting in now.

Purchase chairs for Justice Center from Quill for \$12,629.48.

Per Judge Lapham, will have an Open House at the end of the month before anyone moves in. Hope to start moving offices in April. Will have Open House in the evening after next Court which is March 28, 2022. Movers haven't been given a date yet, but sent signed contract to movers and told them to be ready in April. Moving in whether building is ready or not.

Per Commissioner Lamp, setting culvert in parking lot at Justice Center. David Bartay (Goeke Construction) is supposed to put in curb stops on the open end. Will speak with him about parking lot. Per Judge Lapham, there are a couple of handicap spots that can drive right up to the building. Bollards are preferred over curb stops.

Per Commissioner Lamp, will seal coat road by high school with Commissioner Rinn's help.

Per Commissioner Rinn, begin rehab on Skalak and Kenney Hall Roads.

Per Commissioner Cerny, continue with routine maintenance. Still working on Kulow Bridge.

Per Commissioner Reed, continue with routine maintenance.
