10:30 A.M. PUBLIC MEETING REGARDING REGULATION OF ON-SITE SEWAGE FACILITIES

Commissioner King presented a list of questions regarding size of acreage, use of property, quality of water emitted by the Aerobic System, increasing requirements and review of new order by our County Engineer.

Alfonso Acosta was present to answer questions and informed the Court there are approximately 1200 Aerobic Systems in Austin County.

Per Commissioner Ottmer, with regard to the Above Ground Aerobic System, as an exbuilder he wouldn't want anyone telling him what to do on a piece of property that doesn't belong to the County, and as an adjacent homeowner, he wouldn't want neighbors stuff blowing on his yard. He suggested the court find out if there can be restrictions as to what kind of systems could be used.

Per Judge Bilski, the big issue is to get away from untreated water in the air. They have taken a Constitutional Oath to protect the public health and safety of the citizens.

Al Konvicka, resident, feels someone needs to call the State and let them know their requirements of half (½) an acre is not good. The State's regulations have changed eight (8) times in the last ten (10) years.

Reese Turner, resident, asked if the county could set up a rule using an alternative watering system on one acre of land or less? Increasing property size requirements would

only encourage owners to use the Aerobic System, why not encourage alternative systems?

Dan Anderson, resident, wanted to know how these systems are monitored and enforced to be working properly?

Commissioner Reichardt wanted to know the size of acreage that would be big enough that adjacent properties would not be affected in any way?

Per Judge Bilski, they have a new Electronic Safe Program. It's a computer generated system to help track expired and renewals.

Per Commissioner King, Aerobic Systems are a burden to the County. Adding a half (1/2) acre will not make a difference.
