No more than **20 pairs** of ears can be submitted in a calendar month per household. Turn in the fully completed, signed and notarized Bounty Form along with the coyote ears to the Fayette County Extension Office, 255 Svoboda Lane, Room 134, La Grange, Texas 78945. Note that when the County's budgeted amount for the current fiscal (calendar year) is paid out and reached, no more Bounty money will be paid for that calendar year. This will be an aggregate amount for feral hogs and coyotes.
