

**ORDER DESIGNATING DAY OF WEEK AND LOCATION OF REGULAR TERMS AND  
SETTING SCHEDULE OF FAYETTE COUNTY  
COMMISSIONERS COURT REGULAR MEETINGS FOR 2021**

Pursuant to section 81.005 (Terms of Court, Meetings), Local Government Code, Vernon's Texas Codes Annotated, at the last regular term of each fiscal year the Commissioners Court by order shall designate a day of the week on which the Court shall convene in a regular term each month during the next fiscal year.

The Fayette County Commissioners Court Orders that the terms and regular meetings shall be held at the County Seat at the Fayette County Courthouse, 151 North Washington Street, La Grange, Texas 78945 in the Commissioners Courtroom, Third Floor, Room 303, of the Fayette County Courthouse. The Fayette County Commissioners Court designates, sets and Orders that the regular meetings of the Fayette County Commissioners Court during 2021 shall be held on the **second and fourth Thursdays** of each month (except for, as indicated below, when the second or fourth Thursday is a County Holiday); that the weekly terms of the Commissioners Court begin with those Mondays which are followed three days later by the second or fourth Thursdays of each month; and that regular meetings will be held beginning on the following dates:


