## Precinct Description 422 Ammannsville

The precinct boundaries for the election precinct 422 Ammannsville are described and composed of boundary lines as follows:

## BEGINNING at the corner and center line of FM 609 and corner and center line of Gebert Road;

Following northeasterly along the center line of FM 609 to the intersection at Knape Road;

Following southerly then easterly along the center line of Knape Road to the intersection at Peeler Road;

Following north along the center line of Peeler Road to the intersection at Thuemler Road;

Following east along the center line of Thuemler Road to the intersection at Census Block 1043;

Following northeasterly along the northeast edge of Census Block 1043 to the intersection at West Radhost School Road;

Following east along the center line of West Radhost Road to the intersection at US Hwy 77 and East Radhost School Road;

Following east then south along the center line of East Radhost School Road to the intersection at Criswell Tributary;

Following the Criswell Tributary northeasterly to the intersection at the northwest corner of Census Block 1007;

Following east along the northern line of Census Block 1007 to the intersection at the northeast corner of Census Block 1007;

Following south along the eastern edge of Census Block 1007 to the intersection at Anders Bottom Road;

Following south along the center line of Anders Bottom Road to the intersection at FM 1965;

Following southwesterly along the center line of FM 1965 to the intersection at Mazoch Road;

Following easterly and south along the center line of Mazoch Road to the intersection at Census Block 1063;

Following east along the north line of Census Block 1063 and Census Block 1071 to the intersection at the northeast corner of Census Block 1071;

Following south along the eastern edge of Census Block 1071 to the intersection at West Sedan Road;

Following south along the center line of West Sedan Road to the intersection at the Fayette/Colorado County line;

Following the Fayette/Colorado county line southwesterly to the intersection at Union Pacific Railroad;

Following west and southwesterly along the center line of the Union Pacific Railroad to the intersection at FM 1579;

Following west along the center line of FM 1579 to the intersection at East Navidad River;

Following northeasterly and northwesterly along the center line of East Navidad River to the intersection at Census Block 1035;

Following northwest along the south line of Census Block 1035 to the intersection at Company Field Road;

Following north along the center line of Company Field Road to the intersection at FM 615/Piano Bridge Road; Following west along the center line of FM 615 to the intersection at Mensik Road;

Following north along the center line of Mensik Road to the intersection at the northeast corner of Census Block 1032;

Following west then north along the edge of Cense to the intersection at Mazurek Road;

Following west along the center line of Mazurek Road to the intersection at US Hwy 77 and FM 956;

Following west along the center line of FM 956 to the intersection at Census Block 1002:

Following northwest along the edge of Census Block 1002 to the intersection at Census Block 1000 at Abbotts Grove School Road;

Following west along the south edge of Census Block 1000 to the intersection at Guettermann Ehler Road;

Following west and then north along the center line of Guettermann Ehler Road to the intersection at the southeast corner of Census Block 1001;

Following west along the southern edge of Census Block 1001 to the intersection at Schulze Road; Following west along the center line of Schulze Road to the intersection at Gebert Road; Following north along the center line of Gebert Road to the beginning point of FM 609 and Gebert Road. ENDING at the corner and center line of FM 609 and corner and center line of Gebert Road;
