## **Precinct Description 316 Flatonia**

The precinct boundaries for the election precinct 316 Flatonia are described and composed of boundary lines as follows:

## BEGINNING at the Fayette/County Gonzales County line and intersection at the north edge of Census Block 3030;

Following southeasterly then southwesterly along the county line to the intersection at Fayette/Lavaca County; Following east along the Fayette/Lavaca County line to the intersection at FM 957;

Following northeast along the center line of FM 957 to the intersection at Krupala Lane;

Following north along the center line of Krupala Lane to the intersection at Kainer Road;

Following west along the center line of Kainer Road to the intersection with the southeast corner of Census Block 1076;

Following north along the eastern line of Census Block 1076 to the intersection at Wolters Road;

Following east along the center line of Wolters Road to the intersection at the southeast corner of Census Block 1074:

Following north along the eastern edge of Census Block 1074 and 1069 to the intersection at Marty Road; Following north along the center line of Marty Road to the intersection at the Union Pacific Railroad and US Hwy 90:

Following west along the center line of the Union Pacific Railroad and US Hwy 90 to the intersection at the southeast corner of Census Block 1037;

Following north along the east line of Census Blocks 1037, 1038, and 1008 to the intersection at Freyburg Hall Road;

Following north along the center line of Freyburg Hall Road to the intersection at FM 2238;

Following west along the center line of FM 2238 to the intersection at Freyburg Store Road;

Following west along the center line of Freyburg Store Road to the intersection at Salem Freyburg Road;

Following north then west along the center line of Salem Freyburg Road to the intersection at Gebert Road;

Following north along the center line of Gebert Road to the intersection at FM 609;

Following south along the center line to the intersection at East Parker Road;

Following north and then west along the center line of East Parker Road to the intersection at West Parker Road; Following west along the center line of West Parker Road to the intersection at Old Smithville Road;

Following north along the center line of Old Smithville Road to the intersection at the northeast corner of Census Block 3035;

Following northwest along the east line of Census Block 3035 and 4020 to the intersection at Roy Road;

Following south along the west edge of Census Block 4020 to the intersection at Census Block 3035;

Following south then west along the edge Census Block 3035 to the intersection at Census Block 3033;

Following west along the north edge of Census Blocks 3033, 3032, and 3021 to the intersection at the northwest corner of Census Block 3021;

Following south along the west edge of Census block 3021 to the intersection at Three Mile Road;

Following west then north along the center line of Three Mile Road to the intersection at FM 1115;

Following north along the center line of FM 1115 to the intersection with northeast corner of Census Block 3022;

Following west along the north edge of Census Blocks 3022 and 3027 to the intersection at Elm Creek Road;

Following west and then south along the center line of Elm Creek Road to the intersection with Bar Ranch Road and Census Block 3030;

Following west along the north edge of Census Block 3030 to the place of the beginning;.

ENDING at the Fayette/County Gonzales County line and intersection at the north edge of Census Block 3030;
