

Precinct Description 425 Schulenburg

The precinct boundaries for the election precinct 425 Schulenburg are described and composed of boundary lines as follows:

BEGINNING at the corner and center line of Union Pacific Railroad and the Fayette/Colorado county line;

Following the Fayette/Colorado county line southwesterly to the intersection at the Fayette/Lavaca County line;

Following westerly along the Fayette/Lavaca County line to the intersection at Baumgarten Road;

Following north along the center line of Baumgarten Road to the intersection at Kainer Road;

Following west along the center line of Kainer Road to the intersection at Census Block 1082;

Following north along the western edge of Census Block 1082 to the intersection at Wolters Road;

Following east along the center line of Wolters Road to the intersection at the southwest corner of Census Block 1073;

Following north along the western edge of Census Block 1073 and 1072 to the intersection at Marty Road;

Following north along the center line of Marty Road to the intersection at the Union Pacific Railroad/US Hwy 90;

Following west along the center line of the Union Pacific Railroad/US Hwy 90 to the intersection with Census Block 1050;

Following north along the western edge of Census Blocks 1050, 1039, 1040, 1041, and 1010 to the intersection at Freyburg Hall Road;

Following north along the center line of Freyburg Hall Road to the intersection at FM 2238;

Following west along the center line of FM 2238 to the intersection at Freyburg Store Road;

Following west along the center line of Freyburg Store Road to the intersection at Salem Freyburg Road;

Following north then west along the center line of Salem Freyburg Road to the intersection at Gebert Road;

Following north along the center line of Gebert Road to the intersection at Schulze Road;

Following east along the center line of Schulze Road to the intersection at Census Block 1005;

Following east along the north edge of Census Block 1005 to the intersection at Guettermann Ehler Road;

Following east along the center line of Guettermann Ehler Road to the intersection with Census Block 1006;

Following east along the north edge of Census Block 1006 to the intersection at Abbotts Grove School Road and Census Block 1010;

Following southeast along the northeast edge of Census Block 1010 to the intersection at FM 956;

Following east along the center line of FM 956 to the intersection at US Hwy 77 and Census Block 1016;

Following east along the north edge of Census Block 1016 to the intersection at Mazurek Road;

Following east along the center line of Mazurek Road to the intersection at Middle Creek Road;

Following south then east along the center line of Middle Creek Road to the intersection at the northwest corner of Census Block 1032;

Following east along the north edge of Census Block 1032 to the intersection at Mensik Road;

Following south along the center line of Mensik Road to the intersection at FM 615;

Following east along the center line of FM 615 to the intersection at Company Field Road;

Following south along the center line of Company Field Road to the intersection at the northwest corner of Census Block 1036;

Following southeasterly along the northeast edge of Census Block 1036 to the intersection at the East Navidad River;

Following southerly along the center line of the Navidad River to the intersection at FM 1579;


Following east along the center line of FM 1579 to the intersection with the Union Pacific Railroad;

Following easterly along the center line of the Union Pacific Railroad to the beginning point at the Fayette/Colorado County line;

Ending at the corner and center line of the Union Pacific Railroad and the Fayette /Colorado County line.
